NOTICE OF COMMENCEMENT GUIDELINES

- Provide individual applying for permit with two (2) copies of the Notice of Commencement form;
- Provide individual applying for permit with the Florida Department of Business and Professional Regulation pamphlet;
- If the property owner is not the individual applying for the permit provide property owner with the Florida Department of Business and Professional Regulation pamphlet- Pamphlet can be sent via mail, email, fax, etc;
- Ensure that each permit/contractor has a separate Notice of Commencement;
- Permit can be issued without a submitted Notice of Commencement. However, a Notice of Commencement must be submitted before the first inspection on the property.
