My 6 year old is currently attending Somerset Gables.</p> <p>I would like to briefly share my personal experience regarding the hardships and process of school admissions with my son last year. I would also like to express my admiration and gratitude for Somerset Gables, and how clearly there is a need to expand the school.</p> <p>Last year, my son who at the time was 5 years old, was ready to go into Kindergarten. I am so grateful that we had this opportunity. Rather, just like any other business or educational facility, Somerset must either modify its business model or seek a site which is more suitable for its model. • A 1968 Restrictive Covenant was signed by UBC and the City, declaring that the property would not be leased or used in violation of any ordinances of the City; that part of the property shall not be leased separately from the rest; and that the covenants shall run with the land and be binding upon the trustees and their successors. A covenant is a promise between the City and UBC, and is not to be breached. • Despite Somerset’s representations to the contrary, the proposed traffic patterns will greatly increase traffic in a quiet residential neighborhood. At a recent town hall meeting held at UBC, a police officer from a neighboring city cited his concern based upon professional experience and stressed that traffic during the extended morning and afternoon pick up will present a hardship to this neighborhood. He even suggested that the traffic could be alleviated by building a 6 floor parking garage. • We are not opposed to the charter school, just a school of that size in that small of a space in our residential neighborhood. At the City Commission meeting last spring, the City offered Somerset Academy a compromise number of 210 students. We stand in agreement with that option and feel that it is the maximum number the site and neighborhood can support. Somerset rejected the offer since this number does not

						<p>pay their experts to come up with a traffic study that will downplay the issue of traffic, but it defies logic to think that having over 700 children dropped off and picked up daily will not lead to an increase in traffic that will potentially be hazardous. The traffic will most certainly be a nuisance. And, of importance to me and the surrounding neighbors, will definitely decrease the value of our homes.</p> <p>Next is the issue of what a change in zoning for this piece of property might mean in the long term future. Apparently the requested change can open up that location to occupants that are terribly contrary to the peaceful enjoyment the neighborhood now shares. The thought of a fire station or electric station down the block from our house is most unpleasant. How can it be fair that we purchased our home knowing exactly what was here in our long established neighborhood and then we get the rug pulled out from under us with this potential change?</p> <p>I also don't understand how it is allowable that the area residents will be made to suffer with the opening of a for profit charter school in Coral Gables when most of the student body of the school is from outside of Coral Gables. Increased traffic <ul style="list-style-type: none"> • A majority of the school's supporters live outside Coral Gables requiring them to drive their children to school. • Many of the Coral Gables residents who might send their children to the school do not live within walking distance of the school • A school of 735 students will likely result in at least 1,000 additional vehicle trips traversing my neighborhood daily. • While traffic studies may indicate that the roads can handle this excess traffic, the quality and character of life in the neighborhood cannot. • The beautification of Segovia (a long overdue project) resulting in one lane of traffic in either direction will likely result in more traffic using side streets not designed as main thoroughfares. • Somerset, and its parent company, Academica, have a poor record in addressing traffic concerns in other communities (South Miami, Redlands) • Coral Gables has previously ruled against commercial projects in residential neighborhoods with smaller proposed traffic impacts than what is proposed by the expansion of Somerset Grace. 2. Proposed UBC expansion of activities <ul style="list-style-type: none"> • In a February 2011 letter to UBC members, Pastor White announced that the Church has given up on its plans to move outside Coral Gables and instead will expand its activities at its current site. • None of the discussions or proposals to date has addressed the expansion of the school and the Church and its impact on traffic. • It is likely that both the Church and the school will conduct day and evening activities (church business, parent teacher conferences, school plays, evening prayer meetings, youth group activities etc ...) impacting the neighborhood from sunrise to long past sunset. 3.
