Growing up, my parents always strived to give me the best education that money could buy. At the time (right or wrong), there was a belief that spending money guaranteed you a great education. I left Miami to attend college at Villanova University where I realized that many of my peers never went to private school. I have to admit this seemed odd to me. However, I quickly learned that my peers were just as well or even better prepared than I was for a difficult college curriculum. My husband went to public school his entire childhood. He received a fantastic education scored well on his entrance exams and was extremely successful academically at Villanova. He's opened my eyes to truly believe that a public education can and should work for our kids. Times have changed and many new parents of my generation can't easily pay for a private education the way our parents did for us especially when we are saving for growing college tuition costs. Where does this leave us?</p> <p>After college, I spent 12 years living in various neighborhoods within NYC. I always knew that I wanted to return to Coral Gables to raise my family and in 2008 I finally convinced my husband that it was time. We spent 18 months living with my parents because we were looking for that perfect home in the perfect neighborhood. The perfect neighborhood means to me having excellent public school options. However, I have learned that this concept does not really exist in Coral Gables. I remain shocked about how different things are here vs NYC. In NYC, it is known that the hardest neighborhoods to live in (most expensive) are those with the best schools. This is not a coincidence. We need to move beyond feeling that private school is the only option for our kids or the controlled choice which, as we all know, is not much of a choice at all but rather where you end up being placed.</p> <p>My son's name is Hugo. He is entering Kindergarten next year. The other kids from his small Montessori know where they will be going to school next year. My son keeps asking me and I just don't have an answer for him.</p> <p>I urge the city commission to vote in favor of a significant expansion of Somerset Gables. We live a 1/2 mile away from the school and truly believe that its an excellent idea to have</p>

As a resident of Coral Gables with school-aged children, I consider the issue of education to be paramount—and the one that will be the basis on which I will vote in the coming election.</p> <p>The public education options in Coral Gables, and beyond, are currently insufficient for demand. As an example, my son was placed 185th and 233rd on waiting lists during the kindergarten magnet application process last year, at Henry West Lab and Ada Merritt, respectively. This year, we are again on a waiting list, this time at Sunset Elementary and Ada Merritt for first grade. Unfortunately, I do not know his place on those waiting lists, but nonetheless, another anxious cycle is taking its course with an unknown outcome.</p> <p>Beyond the magnet application process, we participated in the Gables controlled choice process last year and were placed on the waiting list at Sunset. Ultimately, my son did not receive a slot at Sunset and we were directed to Carver Elementary. Unfortunately, the educational offering and test scores at Carver are not comparable to those at Sunset. Perhaps it also means that your home and business are more vulnerable to crime, because if individuals in our community do not have high quality options throughout their school-aged years, they may become financially unstable and may make destructive or criminal decisions in the future—and your family or your business may be a victim of their acts. Beyond the negative, a community is comprised of not just folks that have lived here for twenty years, but those that arrived a few years, months or days ago. Further, it is comprised of people with both foreign and United States passports. The needs and aspirations of all members of the community matter. <p>Gables residents look to our elected officials to consider the needs of all community members—from the most senior to the most youthful. A strong, accessible, educational system is critical to making Coral Gables and Miami world class. A city can be beautiful, but it must also be strong. Charming buildings and well landscaped roundabouts do not make a city robust—nor do they ensure the future of a place. Education has always been the path to prosperity. Perhaps a corollary is that lack of education leads to poverty. 						<p>It would not only be a terrible shame, but a detriment to the 1,300 families in this community who have expressed a desire for their children to attend this school if the requested increase in Somerset Gables student enrollment is not approved by the City of Coral Gables.</p> <p>While we genuinely respect the rights of individuals who are against the school to voice their opinion, much of the information they have been communicating is simply inaccurate. Without schools to accommodate a growing community, stagnation is inevitable. Why live here if we cannot send our child to a nearby public school? That is simply not an option. We need to embrace this step, which is crucial to the educational infrastructure of our City's future generations.</p> <p>Somerset Gables respects the values we hold dear in Coral Gables, including the necessity to minimally impact the quality of life for the surrounding residences. We are celebrating this unique opportunity to grow a wonderful school with most of our neighbors, who are informed as to what the plans exactly entail and what they do not.</p> <p>A mindset that says "nothing can change" is not only shortsighted, but one that in the long-term is sure to damage the many positives that make Coral Gables one of the world's most desirable places to live.</p> <p>A majority of those running for public office in Coral Gables have frequently addressed the need for international companies to invest in Coral Gables. How do we draw major companies to our city without more good schools? 					<p>My family and I vehemently object to the proposed amendment to the Coral Gables Comprehensive Plan that will allow an increase in student population at University Baptist Church from 110 to 735. PLEASE DO NOT ALLOW THIS TO HAPPEN!</p> <p>We live on Camilo Avenue, one block away from the proposed site and our objection is twofold: the obvious being the immediate, negative impact a school of this size will have on our neighborhood and secondly, the potential precedent the amendment change will set for future businesses who could attempt to amend the city's master plan for other private monetary gain.</p> <p>Over the past ten months, others have spoken very eloquently about the repercussions of a 735 student body on our neighborhood. Major issues stand repeating: traffic and increased activity to our residential area. We are especially nervous about the proposed traffic pattern that will wind buses and cars around our house. At a recent "town hall meeting" held at UBC, a police officer from a neighboring city cited his concern based upon professional experience and stressed that traffic during the extended morning and afternoon pick up will present a hardship to this neighborhood.</p> <p>We also are concerned about hours of operation of the building. If it is like any other school, activity will be constant. What about afterschool programs, especially for the middle school students? What about night time open houses and events for parents? This is will affect the neighborhood and is not in line with how it was developed.</p> <p>While the focus is the 735 students, what about the number of staff members it will take to support a school this size? Our estimate is that it will add at least another 75 people (teachers, janitors, aides, office staff) driving to the site – where will they park? During Sunday morning during church services, church members are consistently parking along Cardena and on Riviera Drive directly under the No Parking signs - sometimes on private property because there are few options. This will be even worse, we believe, with a school of this size.</p> <p>We moved to this section of Coral Gables just over 3 years ago. My wife and I did extensive research before we used the majority of our life savings to pay over one million dollars for our home. We knocked on doors and found out that many of our neighbors have lived here over 30 years and expressed what a quiet, beautiful section of Coral Gables this is/was. UBC has been a good neighbor. We are EXTREMELY concerned that our investment and our home are now in jeopardy. We are concerned about Somerset Academy parents using the alley way adjacent to our house in the morning and afternoon as a short cut to the school and preventing us from getting out of our own driveway. This is not what we bought into, and certainly not what we believe the City of Coral Gables would support.</p> <p>We are not against the charter school, just a school of that size in that small of a space in our residential neighborhood. We were present at the City Council meeting when the City offered a compromise number of 210 students. We stand in agreement with that option and feel that it is the maximum number the site and neighborhood could support. If the city really does need an additional school of this size, then careful planning must be made to accommodate students – find a space where there can be a field, a library, in a section of town that is more appropriate. 

We are writing you today to urge you to grant the school's application to allow its expansion at the current location at UBC.</p> <p>We are aware that there is a small but vocal minority that object to the school. However, we believe that the school's presence and how it has and continues to conduct itself as a responsible stakeholder in our community will allay the fears and concerns of its opponents.</p> <p>As we understand it, the main objection to the school's expansion is that some are worried about a "significant traffic event" everyday at drop-off and pick up. We believe that the results of the traffic studies conducted by Somerset will show otherwise. The families and students that are part of the Somerset community are neighbors and citizen stakeholders who do not want to detrimentally affect the adjacent area.</p> <p>Please be assured that we would be respectful of the area surrounding the school and would avoid driving in their area to minimally impact the neighborhood. The children that attend the school are from good families that predominate across the City of Coral Gables. We believe this objection is the least rational of all and really a distraction.</p> <p>The way we have been treated by the City of Coral Gables is a great source of frustration. It is very obvious that a decision on this application has been unduly delayed.
